Re: Rental of building or horse stalls on the Gouverneur Fairgrounds for Fall 2019 through Spring 2020. For horse stall rental contact us at the number below.

Storage entry is available starting September 15, 2019 and exit must take place between April 15, 2020 and May 31, 2020. Some of our facilities may need removal of stored units before the May 31 deadline due to events. In no case will we need a unit removed before April 15th. The required removal date will be defined as units are put in for the winter. Any unit left after the removal date will have a \$25 per week fee assessed. Some buildings require the earlier exit and we will to the best of our ability store units needing later exit dates in buildings where the early exit is not needed.
